GENERAL DATA

Disposable container for sharp and cutting objects disposal. Item designed for low volumes of waste (care tray, trolley, domestic care, doctor's office)

- ► Material: Plastic material 100 % virgin Polypropylene
- Colour: Yellow body and red lid in order to signal the dangerous content.
 Materials coloured with masterbatch without heavy metals and cadmium. Materials compliant to REACH
- Shape: Truncated cone
- ► Weight: 365 gr.
- Max Load: 2.400 gr.
- ► Nominal Capacity: 5,000 Lt.
- **External dimensions:** Ø 214 x 195h mm (body and lid assembled)
- ► Base dimensions: Ø 1
- Ø 182 mm

INSTRUCTIONS

Lid assembly:

Firmly press on all the perimeter, until the lid clicks on the body



• **Temporary closure** The container could be temporarily closed using the cap upside down. At this stage, closure is temporary



USE: ► During use, close the cap in temporary closure position



IMPORTANT!

Before use, press on the anti-reflux fins in order to create a funnel-shaped opening. This device eases the insertion of the waste and creates a barrier to prevent from leakage



Permanent closure

The container could be closed permanently applying pressure on the cap until it clicks on the lid. At this stage, closure is permanent



 Close the container permanently once full



- Large opening to ease the disposal of scalpels, test tubes, etc
- Autoclave Suitable to autoclave at 134° for 18 minutes
- Once filled, the containers have to be disposed through incineration, releasing no toxic emissions

PBS 5



Needles removal:

Use the "V" removal device to separate needle and syringe

Insulin pens removal:

Use the "marguerite" device to unscrew the insulin pen



AVAILABLE HOLDERS:

Trolley/wall bracket



ADVANTAGES:

- ► Lid provided with safe closure device, permanent closure, prevents from waste reflux
- Easy to use and to handle
- Sharp and cutting objects resistant
- Handles available
- Lid provided with needles removal devices
- Suitable to autoclave (compliant to NFX 30-511 even after sterilization)
- Maximum filling level indicated
- Several holders available
- Irreversible permanent closure
- ▶ To be disposed through incineration, releasing no toxic emissions

SAFETY INFORMATION:

- Do not use the product before fitting the lid
- Do not attempt to rescue objects already in the container
- Respect the filling level indicated
- Use the container only with appropriate lid
- > Do not try to open the container once permanently and irreversibly sealed
- ► Follow the instructions of use to ensure the safety of the container
- Container to dispose according to the existing law
- Use handles to move the container
